# **A BILL**

To extend the authority for the establishment of a commemorative work in honor of Gold Star Families, and for other purposes.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4        *This Act may be cited as the “Gold Star Families Na-*  
5 *tional Monument Extension Act”.*

6 **SEC. 2. EXTENSION OF AUTHORITY FOR ESTABLISHMENT**  
7 **OF COMMEMORATIVE WORK.**

8        *Notwithstanding section 8903(e) of title 40, United*  
9 *Sates Code, the authority provided by section 2859 of the*  
10 *Military Construction Authorization Act for Fiscal Year*  
11 *2013 (division B of Public Law 112–239; 126 Stat. 2164;*  
12 *40 U.S.C. 8903 note) shall continue to apply through Janu-*  
13 *ary 2, 2024.*
